The villagers go as migrants during sugarcane harvesting season. The discussion held with Sarpanch, Gramsevak and villegers conclude that there is insufficient water . There is severe water scarcity. Handpumps are dried. Hence proposal of rain water harvesting was prepared and a PPT presented before UBA, West Zonal Committee, Dr.BAMU,Aurnagabad, in the meeting held on 22.06.2022 . The same proposal is uploaded in Tech4Seva to UBA cell ,IIT ,New Delhi.
